In addition to the normal code enforcement cases, the project continues to verify pool compliance for permits and final inspections; and continued efforts require staff to enforce the silt fence ordinance. Assistance in the permit center continues to be provided; as well as, Energov training and cross training staff.

Stormwater Report for Council, June 2022

Working with NC Coastal Federation and resident Paul Larkin (W. Yacht Dr.) on a Living Shoreline Project across private and Town property. The project utilizes wave energy dissipater structures and bagged oyster shells to protect our marshland, encourage new oyster beds, and reduce soil erosion. The project is currently, being reviewed and should be at no cost to the Town.

Routine stormwater ditch cleaning and reseeding activities continue. Recently secured NC native wildflower seed mixture for planting in highly visible areas requiring less maintenance.

Our new stormwater crew is doing an excellent job. Their enthusiasm to provide professional-high quality work, customer service, and improve our stormwater program has been exciting. We have been trying out (at no charge) several different brands of excavators comparing performance, lifting abilities, and costs. The crew repaired and refurnished our aging pipe trailer saving thousands and making it road ready again.

Recently purchased two (2) truck-loads of commonly used 15 inch plastic pipe allowing maximum savings per foot. Additionally, we are utilizing a different stone/rock vendor where savings average \$5-15 less per ton for the same NCDOT certified materials. We are currently enlarging and improving our lay down area (at the airport) for pipe and stone to maximize our cost savings for larger quantities.

Working with new Planning Section along with Development Services to improve services to the public. I have been working with GIS Graduate Intern to update, correct, and improve stormwater maps.

We continue to struggle with getting NC-811 utility locates in a timely manner. The call three (3) days before you dig concept has been averaging over 30 days with multiply follow-up calls. I have been in discussion with the locate company servicing our area without much improvement. Council may want to consider our legal options to address this continuing problem.
