

LAND USE PLAN UPDATE

STAKEHOLDERS GROUP APPLICATION

There are several ways citizens can participate in the Land Use Plan update. Besides general public engagement activities the Town's consultant will lead, there will also be a Steering Committee, which will meet several times throughout the update process. If you want to be involved with less of a time commitment, participating in one of the Stakeholders groups might be the right fit.

Each stakeholder group will meet with the consultant for approximately one hour (meeting date and time to be determined). Stakeholder groups will include 4-6 citizens in each of the following categories:

- Group 1: Land Planners, Architects, Landscape Architects, Engineers, Surveyors, Developers, Realtors, Home Builders Assoc., Etc.
- Group 2: Appointed and/or Citizen Board Representatives (Business Advisory, Parks/Rec, Environmental Advisory, Fire/Police, etc.)
- Group 3: Business Groups (non-development, real estate related), Major Employers, Economic Development, Chamber of Commerce, Tourism
- Group 4: Citizen Groups, Neighborhood Activists, Environmental Groups, Community Leaders, etc.
