## Beach Nourishment Updates

During the **April 8 Town Council meeting**, Town Manager Kathryn Adams provided several key updates on current and upcoming Beach Nourishment projects.

- The **Lockwoods Folly Inlet** project currently underway and servicing the West end (The Point) began on April 1 and just reported a **volume increase** from 65,000 cubic yards to 105,000 cubic yards of sand. This is being placed West End, from The Point extending to the 6700 block of W Beach Dr. at a 75ft+ width. To view a map of the service area, [\*\*CLICK HERE\*\*](#).
- Additionally, the **Wilmington Harbor** project servicing the EAST end was rebid by the U.S. Army Corps of Engineers (USACE) on April 1. The Town has been presented with an option to accept 600,000 cubic yards of sand for \$6.6M, per the contract with USACE signed in September 2024. During the update, the Town Manager recommended to Council to exercise both extension options. To view a sand placement map for this project [\*\*CLICK HERE\*\*](#).
- The extensive **2025 / 26 Renourishment Project** (OSOKI) which will service the entire beachfront, now has a finalized lease by the **Bureau of Ocean Energy Management** (BOEM). Contracted engineering firm **Moffatt & Nichol** will rebid this project this week, and hold bid openings on May 12.

## Outside Agency Funding Updates

A top priority for the Town of Oak Island is to ensure all tax dollars are used in the best possible manner for the benefit of our citizens. To help achieve this, recent updates have been made to the qualifications and requirements for the way funds are provided to specific programs. These updates have replaced the previous funding methods for general nonprofit services and operations.

The purpose of this policy is to promote partnerships between the Town of Oak Island and non-profit agencies for the benefit of Oak Island residents, to equitably and efficiently allocate resources to strengthen agencies, and to provide sound and clear methods for decisions.

The **NEW Outside Agency Funding Application** requires an **Agency Mission Statement, Key Accomplishments, Goals, Objectives**, and information on the specific program(s) for which the agency is requesting funds and how it aligns with the Town's Strategic Plan.

The **Outside Agency Funding Applications** for **Fiscal Year 2025 / 2026** are now available to apply for and include the updated Funding Policy. **PLEASE NOTE: Applications are DUE by close of business on Monday, May 5, 2025.** Applications can be downloaded from the **Form Center** page at [\*\*OakIslandNC.gov/FORMS\*\*](http://OakIslandNC.gov/FORMS) or by clicking the link below.

## CPR + AED Class Success!

Last week, we announced a **combined CPR + AED Training**, following the installation of a **NEW Automated External Defibrillator (AED)** in the ball courts at the Middleton Park Complex. This training was highly beneficial and timely, as just the day before installation, an AED had been used on the Pickleball court to restore the pulse of an individual in cardiac arrest.

This past **Thursday, April 10** and **Friday, April 11** we offered this Town of Oak Island's combined training course to an amazing reception. We saw several pickleballers and generally interested citizens show up to this free course, to learn life-saving techniques and operation of these life-saving devices.

## SLOW RIDE: *Take It Safely*

It's a familiar story. The weather is getting warmer, the sun is shining more, and you want to dust off the ol' cart for a ride down to Middleton Park. Between residents' rides, rental runarounds, or even registered **Mobility Devices**, the traffic will only be increasing with for these **Low Speed Vehicles (LSVs)**.

That's why it seems like a great time to remind everyone of our **SLOW RIDE: *Take It Safely*** campaign for Low Speed Vehicles.

Just like when we first launched the campaign last year, we'll continue our LSV enforcement, and focus on education with our **LSV Information Cards**, which you can also download at [OakIslandNC.gov/LSV](http://OakIslandNC.gov/LSV).

These cards feature a map that gives LSV drivers alternative routes to use so they can enjoy a nice "***Slow Ride***" without impacting the heavier traffic on streets like Oak Island Dr. and Beach Dr.

Remember, **LSVs are treated just like any other vehicle on the road**. We respect their right to enjoy our streets as much as any other vehicle, and apply the law equally. By providing these safety reminders and helpful route suggestions, we can work together to let everyone enjoy the Island at their own pace.
