




Town of Oak Island Monthly Financial Report

2026 Anticipated (Blue) vs Revenue (Green)








Budget vs Expense (Enc/Req included based on above controls) by Year

October 2025 Division Report – Planning & Zoning

Division Update

In September, Development Services launched the long awaited online permitting portal for the Town of Oak Island. The portal allows property owners and applicants to skip the permitting desk and submit their zoning, building, stormwater, and business applications from the comfort of their own home or office. The new online system also improves property owners' access to previously issued permits by providing a search feature for older records associated with their address. Additionally, property owners who have received a notice of violation from code enforcement will be able to see status updates and assessed fines in real time. Getting started with the portal is as simple as setting up a user account! Instructions for account set-up and a user guide are available on the Town's website on the Development Services page. The portal aims to support the goal of decreasing the total time needed for permit review and approval upon submission of a complete application.

As you may have seen in previous editions of 'The Current', the Planning and Zoning division initiated a public awareness campaign on solid waste and yard debris left in the right-of-way also known as "curb dumping". The "Curb Alert!" campaign aims to increase public awareness of what is and isn't permitted to be disposed of adjacent to the street. When discarded items are left streetside for multiple days they pose a danger to the environment, property and are aesthetically unappealing. Large branches or tree stumps not associated with typical yardwork may damage Public Work's trucks and are not collected. Our department would like to thank the public for assisting in these efforts by sharing the campaign posts with their friends and family to help get the word out!

Code Cases – Attorney List

Since April, the Planning and Zoning division has made great strides to work with property owners and the town attorney to correct some long-standing code violation cases throughout the town. We have achieved success in pursuing these cases by revamping our organizational system with new file management techniques, updating and enhancing our mailed notices of violation for clarity and focusing on corrective action. We are pleased to announce twenty violation cases have been removed from the attorney list over the past few months with many others near compliance that we hope to remove soon.







During September 2025, several key community engagement activities were conducted, highlighting the department's ongoing commitment to outreach and public safety. 
Moving forward, this quarterly program will continue to serve as a valuable touchpoint for maintaining positive engagement with the senior community.



Looking Ahead – October 2025 Agenda

The Oak Island Police Department will continue its commitment to safety and community engagement in the coming month through both traffic initiatives and outreach events.

Oak Island Speed Trailer Initiative

To promote safe driving and address community concerns, the department has reestablished the Speed Trailer Initiative. Each week, the portable speed trailer will be placed in different areas of Oak Island, with locations determined by:

1. **Community Reports** – responding to areas where residents have raised concerns about speeding.
2. **Major Roadways** – high-traffic corridors where visibility of the trailer serves as both an educational tool and deterrent.

The trailer provides drivers with real-time speed feedback, reminding motorists to slow down and encouraging voluntary compliance with posted speed limits. By rotating its placement weekly, the department can maximize coverage and reinforce safe driving habits throughout the island. This initiative is educational in nature and designed to promote roadway safety for residents and visitors alike.
